**NOTICE OF COMMENCEMENT OF CASES AND LIVESTOCK OWNERSHIP BAR DATE**

**Commencement of Cases:** Involuntary bankruptcy petitions have been filed against each of the above debtors (collectively, the "Debtors") and orders for relief have been entered in each of their cases. The cases are pending in the United States Bankruptcy Court, Western District of Missouri before the Honorable Jerry W. Venters, United States Bankruptcy Judge. **Livestock Ownership Litigation Procedures:** By an Order dated September \_\_\_\_, 2001, (the "Livestock Litigation Order") the Court has established detailed procedures relating to the resolution of claims to livestock on hand when these cases were commenced.

**LIVESTOCK CLAIMS AND NOTICE OF BAR DATE: NOTICE IS HEREBY GIVEN THAT ALL PERSONS AND ENTITIES, INCLUDING, WITHOUT LIMITATION, INDIVIDUALS, PARTNERSHIPS, CORPORATIONS, ESTATES AND TRUSTS, THAT ASSERT ANY INTEREST IN ANY OF THE DEBTORS' LIVESTOCK, INCLUDING, BUT NOT LIMITED TO, ANY OWNERSHIP INTEREST, SECURITY INTEREST, LIEN, MORTGAGE, OR ENCUMBRANCE, ARE REQUIRED TO FILE A LIVESTOCK CLAIM FORM, WITH SUPPORTING DOCUMENTS BEFORE 4:00 P.M., C.S.T. ON \_\_\_\_\_, 2002 ("THE BAR DATE"). ANY ENTITY THAT FAILS TO FILE A LIVESTOCK CLAIM FORM, WITH SUPPORTING DOCUMENTS, ON OR BEFORE THE BAR DATE SHALL BE BARRED, ESTOPPED AND ENJOINED FROM ASSERTING A CLAIM AGAINST THE DEBTORS' LIVESTOCK.**
