FILING FEES FOR A MOTION TO REOPEN A CLOSED CASE	
<p>The fee charged is the same as the filing fee in effect for commencing a new case on the date of reopening: \$155.00 for Chapters 7 or 13; \$800.00 for Chapter 11; \$200.00 for Chapter 12. If the case had previously been dismissed for failure to pay the original filing fee, both the balance of the original filing fee and the reopening fee must be paid. The fee must be collected when the motion is filed unless the reopening is to correct an administrative error or for actions related to the debtor's discharge. The court may waive this fee under appropriate circumstances or may defer payment of the fee from trustees pending discovery of additional assets.</p>	
FEES FOR CONVERSION TO A DIFFERENT CHAPTER	
<p>A. For Chapter 7 or 13 cases converted to Chapter 11 at the request of the debtor, there is a statutory conversion fee of \$645.00</p> <p>B. For a notice of conversion from a Chapter 12 or 13 case to a Chapter 7 case and for a motion to convert any case to a Chapter 7, there is a statutory fee of \$15.00.</p>
