



Harpool Awarded Law Enforcement Commendation and Medal

District Judge Doug Harpool was awarded the Law Enforcement Commendation and Medal by the Missouri Society of the Sons of the American Revolution (SAR) during their annual State of Missouri Convention on April 24, 2021.

The Law Enforcement Commendation and Medal is one of SAR's top awards and is awarded yearly to one individual in the State of Missouri. The award is presented to those who have served with distinction and devotion in the field of law enforcement and is intended to recognize exceptional service or accomplishment in the field. Eligibility extends to the entire range of individuals who make and

Howard Fisk, who made the initial nomination, Judge Harpool was honored with this prestigious accolade due to his excellent and storied career in legislation and in the law. His dedication to the law has made him an exemplary member of the bar of Southwest Missouri and the State of Missouri due to his performance on the bench, previous work in legislation, and his extraordinary dedication to the court's naturalization ceremonies.


Deeply and humbly honored to receive the award, the Judge stated that democracy is still an experimental form of government, and we must keep working to make it better by improving and changing laws. He mentioned how too many of us forget how special it is to live in a country of laws and that's what makes our country so special.

Viewing Naturalization Ceremonies as a special opportunity and one of his favorite parts of being a United States Judge, Harpool said, "it is always special to see the glow in the eyes of the new citizens and to see how excited they are because many of them lived in a society not based on laws, and they see the opportunity the United States presents." Every ceremony reminds him of the opportunity he has, and it concerns him that so many of us take for granted the wonderful privileges we have. He hopes we never lose sight of our need to bring in new citizens and open our borders legally as the laws require. Mentioning that new citizens are extremely dedicated individuals who have worked hard to comply with the law, Harpool supports the need to continue to welcome new citizens' talents and excitement.

Showing his appreciation for SAR, the Judge stated that he is especially happy with his relationship with the organization and greatly appreciates how they help celebrate our new citizens and truly try to make each Naturalization Ceremony a celebration: "It is as exciting for me and our country to have them here as it is for them to get to be here because they revitalize us and remind us of what an incredible privilege it is to live in this country. So long as I am in this position, I'll fight to see that our laws are respected, and implemented fairly. The more that we respect the way we implement the law, the more likely we can assure that the citizens will be able to respect our courts."

WDMO Opinions on GovInfo

The United States Courts Opinions (USCOURTS) collection is a collaborative effort between the U.S. Government Publishing Office (GPO) and the Administrative Office of the United States Courts (AOUSC) to provide public access to opinions from selected United States appellate, district, and bankruptcy courts. The USCOURTS collection is consistent with the E-Government Act's requirement for the substance of all written opinions, issued after April 16, 2005, to be made available in a text searchable format.

MAP Updates from the Director

It has been an honor to serve as the Director of the Mediation and Assessment Program ("MAP") for more than a year. In 2020, Jill A. Morris became a United States Magistrate Judge after serving as the Director for more than seven years. Navigating a new position in the middle of the COVID-19 pandemic was made easier with significant support from the judges and their staff, Operations, IT and MAP staff members JoAnna Hickman and Melissa Nolte. Melissa was recently promoted to Relief CRD. Though I am sorry to lose her, she will continue to be an asset to the Court.

As attorneys were still transitioning to remote ADR when I started, efficacy questions remained, including ensuring confidential communications in settings which blurred the lines between work and home. Several shared stories from their basements, kitchen tables, and even closets and barns. The transition to remote ADR was replete with bandwidth issues; barking dogs; mischievous cats; children enjoying the game of opening and closing doors, much to their parent's dismay; clothing mishaps; an occasional chatty parrot; and a rambunctious cow. By November 2020, most had adjusted to ADR via Zoom or WebEx, and some embraced in person participation with appropriate safety protocols.

In February of 2021, MAP held its first webinar with more than 200 attendees. I had the pleasure of presenting with The Honorable Jill A. Morris and Joseph K. Eischens. Amy L. Coopman and Vickie Harris provided an insightful presentation regarding implicit bias. Building on the webinar, Jay Daugherty Mediation & Arbitration hosted an informative roundtable in April 2021 regarding the future of ADR, including further ways to foster diversity, equity and inclusion.

The Prisoner Litigation Mediation Pilot Program was implemented in June 2021 and is overseen by The Honorable Stephen R. Bough. The Program involves a collaboration between the MAP Office and Prisoner Pro Se Office following significant work by The Honorable Jill A. Morris and Pro Se Law Clerk and Staff Attorney Greg Doty on the Program's necessary components.

Our bankruptcy and magistrate judges and outside neutrals continue their excellent contributions to MAP, regularly facilitating communications through mediation or other ADR to ensure MAP's purpose is achieved.

Thanks to feedback from The Honorable Jill A. Morris, Magistrate Judge, and The Honorable Cynthia A. Norton, Bankruptcy Judge, MAP is commencing "MAP Quarterly Conversations" in October 2021 to foster dialogue between neutrals and attorneys.


Terri Moore was promoted to Divisional Manager of the Central Division in January 2021, filling the vacancy due to the retirement of Carrie James.


