In typical fashion, Pat reminded us that "we are all temporary trustees of an institution called the Federal Judiciary . . . and it is our job, as trustees, to leave the institution better than we found it." Our staff will work hard to fulfill Pat's charge and to continue to provide the highest level of service, courtesy and professionalism.

And because the word "retirement" is really inapplicable here, I am pleased to report that Pat has recently agreed to serve as Interim Director of the YWCA in Kansas City, Kansas. Best wishes to Pat in this new role and with her many consulting opportunities.

We also extend our thanks to retiring IT Director, Jim McKinney. Jim and his team enable our communications as well as the IT infrastructure that supports electronic filing and the entire array of automated services that are now necessary to keep the wheels of justice turning. We rely heavily on our IT experts, and we thank Jim for his leadership over the past 5 and one half years.

Speaking of IT, the Bankruptcy Court just upgraded to CM/ECF Version 3.3 while the District Court upgraded to CM/ECF Version 4.0. We work to minimize any inconvenience as these improvements are implemented. but some downtime is inevitable. To the extent these upgrades create any filing issue for you in relation to a judicial directive, or in the event of an emergency, you should contact the court by calling 816-512-5000 or after hours 816-985-8576. These and other emergency numbers are posted on our website, and we will find a solution to meet your needs and to maintain compliance with local rules or a particular order.

On another organizational note, effective January 5th, our Probation and Pretrial offices officially consolidated. While this administrative move should not affect external processes or services, it is a significant internal change and consistent with the practices of many federal courts across the country. Chief Kevin Lyon and new Deputy Chief Steve Richert report that the consolidation has been progressing at a good pace, and they continue to make adjustments so the new organization can provide the best possible service to its customers. We applaud our officers and the respective Probation & Pretrial units for accepting this challenge and making it a success.



Also and as you may have seen in the media, the President signed into the law the Omnibus appropriation bill for Fiscal Year 2009 on March 11th. The bill fully funds the government through September 30th. Subsequently, the Executive Committee of the Administrative Office approved the final FY09 financial plan for the judiciary. We are still reviewing the final numbers, but we are optimistic that they reflect sufficient funding for us through our fiscal year end.

Finally, on a personal note, I am glad to be back in downtown Kansas City. After practicing law with the Watson, Ess firm at 1010 Grand, my in-house roles with The Rival Company, and most recently, GE Insurance Solutions (ERC), took me out south. It's great to be back and reconnecting with the members of the Kansas City bar and our revitalized downtown. I look forward to the challenge of the Court Executive/Clerk of the Court position and am learning the ropes from many talented colleagues here in Kansas City as well as Springfield and Jefferson City. JOHN BOWEN RETIRES FROM FEDERAL COURT

John Bowen retired from the Western District of Missouri on January 31, 2009, after 30 years of federal service with The Honorable Howard F. Sachs. John has been a court reporter for 55 years. During that time, he has personally reported the words of every president from Kennedy through Obama at various events where they have appeared.

The genesis of John's interest in court reporting occurred back in the 1950's. He was working as a photographer for the FBI at the time when he discovered that photography really wasn't for him. John craved something more fast-paced. so he attended court reporting school in Washington, DC and graduated in 1954. John took his first reporting job in state court at Norton, Kansas; then he officially moved to Kansas City in 1957 when he took a state court job in Olathe. While working in Olathe, John would pick up some freelance work on the side for the firm of Miles & Behrens. In 1972 when Miles & Behrens was on the market, John bought it and has been in the business ever since.

Before John was officially hired at federal court, he worked on an antitrust case in front of Judge Oliver where he and a colleague produced 28,000 pages of daily copy transcript. This was in 1975, long before computers were commonplace, so they produced all these pages using stencils and a mimeograph machine! When Judge Sachs first came on the federal bench in 1979, Judge Oliver suggested that Judge Sachs hire John to be his reporter because of John's work on the antitrust case, and the rest is history. John has been primarily assigned to Judge Sachs for his entire 30-year career with the Western District of Missouri.



John has a great fondness for Judge Sachs and is proud to have had the opportunity to serve him. John says that Judge Sachs "knows law up one side and down the other." He describes Judge Sachs as a true gentleman in every respect who has a great sense of humor. Their relationship goes beyond just business. It has evolved into a trusted friendship that has spanned decades.

John also stays busy with philanthropic work. After his grandson received a liver transplant several years ago, John and his family established the Gift of Life Foundation (www.giftdonor.org). The purpose of the foundation is to educate people on organ donation. They are currently working with Robert Redford to set up a fundraiser in Kansas City where Mr. Redford would make a personal appearance sometime in 2009 or 2010. Mr. Redford's son also received a liver transplant, and he has formed a similar foundation.

While John has retired from federal court, he has not **really** retired as a court reporter. His freelance firm, John M. Bowen & Associates, is still going strong with John at the helm. Even though we all wish John well in his retirement from federal court, it doesn't look like true retirement is anywhere in John's foreseeable future.

Good luck John! You will be missed.



PRESENTENCE REPORTS NOW ON CM/ECF

Attorneys working with the Court in regards to criminal cases should have noticed a major change in the last month in regards to receiving presentence reports from the Probation Office. Effective February 9, 2009, the Probation Office began uploading the final version of the presentence report onto CM/ECF. Attorneys of record will receive notice through CM/ECF when the report has been completed. They will then be able to retrieve the report at their convenience prior to the sentencing hearing. The same CM/ECF document rule applies; the report can only be accessed once at no charge. At that time, it can be either printed or saved for future reference. If additional information is provided in an addendum, that document is also being uploaded onto CM/ECF and will link back to the presentence report.

Since the presentence report is a sealed document, CM/ECF will need to authenticate that the attorney wanting to view the document is the attorney who has permission to view the document. This is done by the attorney using his/her CM/ECF login. Using a PACER login will not allow access to the presentence report.

The Probation Office believes having the presentence report on CM/ECF should prove of great benefit to the attorneys of record and members of the court family as well.

WIRELESS ACCESS AVAILABLE

Wireless access to the internet by attorneys and staff is available from all district and bankruptcy courtrooms in Kansas City and Springfield.

Local Rule 83.11, adopted in October 2007, authorized the use of laptop computers in the courtroom by members of the bar and their staff. This authority is now extended further to allow access to the internet and the CM/ECF case management system. Please abide by the following if you wish to take advantage of this opportunity.

- Request wireless access to the internet via the presiding judge's courtroom deputy a
 minimum of 24 hours in advance of each court event. Access is made available at the
 discretion of the presiding judge in each case. Any internet access obtained in the
 courtroom must be in support of the court case or business at hand.
- Receive instructions and temporary login and password from courtroom deputy upon approval from judge. Login and password combinations will be valid only for the duration of the matter at hand and a new login /password must be requested for each new court proceeding.
- Ensure your laptop has wireless capability prior to arriving in court. The court does not provide any equipment.
- Allow adequate time for setup prior to court event. The court will not delay any proceedings due to technical difficulties or failures.
- Disable all laptop sound and photo recording features prior to court event.

The Western District of Missouri is excited to offer this opportunity to attorneys and their staff.



CELL PHONES IN THE COURTROOM


JEFFERSON CITY COURTHOUSE UPDATE

A COMMUNITY WORKFORCE INITATIVE

The Employer Development and Referral Program is designed to develop relationships with employers and to educate those employers on the benefits of hiring exoffenders. The U.S. Probation and Pretrial Office is developing a program which encourages employers to contact the Probation Office when they would have a job opening. Upon receiving the notification the Probation Office would pre-screen exoffenders to determine if he/she would be a qualified candidate for the position. A list of these candidates would then be provided to the potential employer.

During the event, Chief District Judge Fernando J. Gaitan, Jr. provided the opening remarks regarding the need to employ exoffenders. Additionally, William H. Dunn, Sr. Chairman Emeritus, J.E. Dunn Construction and Chairman of the Board for





the Second Chance Foundation also spoke of his commitment to this endeavor. The highlight of the event was the panel which consisted of employers, offenders and Senior U.S. Probation Officer Chi King. Buzz Kelsey of Hannah Rubber discussed his positive experience in hiring ex-offenders and the relationship he has developed with the Probation Office. Laura Rupe of Deffenbaugh Industries provided a story of hiring an ex-offender and how his performance and commitment to the job exceeded everyone's expectations. Joyce Heiman, from the Kansas Department of Commerce, presented information on tax incentives and bonding.



TRIAL BY JURY

The Right to Trial by Jury was so important to the founding citizens of this country that it was mentioned in the constitution and twice in the Bill of Rights:

The Constitution of the United States of America

Article. III. Section. 2. Paragraph. 3.

"The Trial of all Crimes, except in Cases of Impeachment; shall be by Jury; and such Trial shall be held in the State where the said Crimes shall have been committed; but when not committed within any State, the Trial shall be at such Place or Places as the Congress may by Law have directed."

Amendment V.

"No person shall be held to answer for a capital, or otherwise infamous crime, unless on a presentment or indictment of a Grand Jury, except in cases arising in the land or naval forces, or in the Militia, when in actual service in time of War for the same offence to be twice put in jeopardy of life or limb; nor shall be compelled in any criminal case to be a witness against himself, nor be deprived of life, liberty, or property, without due process of law; nor shall private property be taken for public use, without just compensation."

Amendment VII

"In Suits at common law, where the value in controversy shall exceed twenty dollars, the right of trial by jury shall be preserved, and no fact tried by a jury, shall be otherwise re-examined in any Court of the United States, than according to the rules of the common law."

GENERATING A CIVIL COVER SHEET

The automated Civil Cover Sheet (JS-44), located on our website under Forms, was developed by the Western District of Missouri to ensure that all necessary information is provided to the Clerk's Office when commencing a new civil action. Please remember that the submission of the Civil Cover Sheet does *not* constitute the filing of the complaint.

A few things to remember when completing the Civil Cover Sheet:

- 1. Please add **all** parties and attorneys when completing the Civil Cover Sheet. If you make an error when adding a party, use the Edit or Delete button to correct the information or remove the party.
- 2. If you are filing a motion to proceed in forma pauperis please check the appropriate box.
- 3. Complete the Cause of Action section, cite the U.S. Statute under which you are filing, and write a brief statement of cause.
- 4. After completing the Civil Cover Sheet, click on the Generate JS-44 button. This will compile all of the completed information into a single form. <u>It is very important to convert the completed document to PDF format BEFORE e-mailing it to the Court.</u> Once converted, the PDF document should be attached to an e-mail and sent to the appropriate division, as listed below and at the top of the Civil Cover Sheet.

Once the Civil Cover Sheet is received in the Clerk's Office, the case will be opened and you will be called to electronically file the complaint. The case is considered filed once the complaint is filed in CM/ECF.

SUBMISSION OF PROPOSED ORDERS

Proposed orders are not to be electronically filed. Proposed orders, with the exception of the proposed scheduling order, should be submitted in WordPerfect or Microsoft Word format to the courtroom deputy for the presiding judge in the case. Please attach your proposed order to an e-mail and send it to the appropriate courtroom deputy. A listing of courtroom deputies and e-mail address can be found on Page 6 of the Administrative Procedures Manual (http://www.mow.uscourts.gov/CMECF/admin.PDF).

ELECTRONIC CASE FILING SYSTERM UPDGRADE

The Bankruptcy Court successfully installed a version upgrade which took effect on March 1, 2009. Beginning with cases opened *on or after* March 1, 2009, additional data entry on chapter 7 and chapter 13 cases is required. This information can be found on <u>Schedule C</u> (for both 7 and 13 cases) and on the <u>Statement of Current Monthly Income</u> (B22A for 7 cases only). This information is needed to meet reporting requirements created by the Bankruptcy Abuse Prevention and Consumer Protection Act of 2005.

Most bankruptcy practitioners experienced little difficulty with the version upgrade.

Beginning with cases opened on or after March 1, or if ordered by the judge, installment filing fees must be paid on-line with a credit card. To make an installment payment on-line, go to Bankruptcy>Other, enter your case number and select the event based on the chapter of your case.

Bankruptcy Events → Other Installment Filing Fee Payment - Ch 13 Installment Filing Fee Payment - Ch 7

Select Next to go to the next screen

Enter Which Payment this is - First, Second, Third, or Final: Second	
Enter the Amount of	the Installment Payment to be Paid
Fee: \$99.00 Next Clear	

Select "Pay Now" at the end of your transaction and input credit card information.

The Bankruptcy Court will not accept cash, checks, or money orders from represented debtors. Attorneys representing debtors should inform debtors to make all payments through their attorney's office allowing additional time between receipt of a debtor's check and the installment payment due date if necessary.

CONGRESSIONAL ACTION: Mortgage "Cram Down"-HR1106/SB61

The House passed HR 1106, the "Helping Families Save Their Homes Act of 2009" on March 5, and it was initially thought that the Senate could take up the matter on the following week. As of this printing, the Senate has yet to take up the bill.

With Congress due to start a two-week recess on April 6, Senate negotiators have been unable to secure the 60 votes needed to get the bill through the chamber.

The key issue is what types of mortgages should be eligible for Chapter 13 cramdown – where the bankruptcy judge can divide a mortgage claim into a secured and an unsecured claim.

NEW MISSOURI JURY ORGANIZATION

The inaugural meeting of the *Missouri Jury Organization* was held February 5, 2009 at the Charles Evans Whittaker Courthouse. The purpose of this organization is to unite the federal and state courts resources in support of juror education. Attendees included jury management teams from the U. S. District Court, Western District of Missouri; the U. S. District Court, Eastern District of Missouri; the State of Missouri, 16th Judicial Circuit Court; the State of Missouri, 7th Judicial Circuit Court; a representative from the Office of the State Courts Administrator and a representative from the Missouri Bar. Our goal is to improve the public's perception of jury service at both the state and federal level with committees being formed to focus on a juror education brochure and planning for juror appreciation week scheduled in May, 2009. As our organization advances, we will begin to reach out to other courts in the state to be representatives by providing information to the citizens of their respective jurisdictions. The second meeting of the new organization was held March 25, 2009, via video conferencing.

CJA INFORMATION AND ANNOUCEMENTS

IMPLEMENTATION OF HOURLY RATE AND CASE MAXIMUM INCREASES FOR CRIMINAL JUSTICE ACT PANEL ATTORNEYS

Increases in CJA Panel Attorney Hourly Rates

Congress authorized and provided funds to raise the non-capital hourly panel attorney compensation rate from \$100 to \$110, and the maximum hourly capital rate from \$170 to \$175 (for federal capital prosecutions and capital post-conviction proceedings). These rates apply to attorneys appointed to represent eligible persons under the CJA, 18 U.S.C. § 3006A, and the Antiterrorism and Effective Death Penalty Act of 1996, codified in part in 18 U.S.C. § 3599.

The new hourly compensation rates apply to work performed on or after March 11, 2009.

Where the appointment of counsel occurred before this effective date, the new compensation rates apply to that portion of services provided on or after March 11, 2009.
