PAYMENTS THROUGH PAY.GOV

 - a. Please do not click on the back button when you are in the middle of paying a fee.
 - b. If the screen freezes, please do not pay again. Please check for payment the following day
 or contact Mindy or Cecelia to confirm if payment was received.

SERVICE OF MOTIONS FOR RELIEF AND NOTICE AND ORDER SETTING HEARING

- a. Creditors MUST serve the debtor by mail and include debtor's name and address in the certificate of service.
- b. Service of both the motion and notice at the same time is acceptable; however, the certificate of service should be filed as soon as service is made.

FINAL APPLICATION FOR COMPENSATION IN CHAPTER 13 HOURLY FEE CASES

- a. Please remember that a final fee application requesting approval of all interim fee awards must be filed at the end of the case before it is closed.
- b. A Clerk's Note will be entered on the docket at the beginning of the case with this reminder and the case will have an additional flag entitled HRLYFees.

ESR (ELECTRONIC SELF-REPRESENTATION)

- eSR is now available for Chapter 13 pro se debtors.

MORTGAGE FORBEARANCE AGREEMENTS

- Bankruptcy Events → Motions & Related Filings → <u>Notice of Debtor's Request for Mortgage</u> <u>Forbearance Due to the Covid-19 Pandemic</u>
- Should be filed by the creditor.
- No action will be taken by the court on this notice.
- If the notice relates to a conduit mortgage, the trustee will file a <u>Trustee's Motion for Order On Mortgage</u> <u>Forbearance</u>.
