eReaf and eRQN

- The court has added two new electronic filing options to its website.
- Electronic Reaffirmation Agreement (eReaf) is a program designed to allow creditors or attorneys to file a Reaffirmation Agreement via the internet without having to log into CM/ECF. ONLY a Reaffirmation Agreement WITH cover sheet in a combined PDF should be filed through this feature.
- Electronic Request for Notice (eRQN) is a program designed to allow creditors to file a Request for Notice via the internet without having to log into CM/ECF. A PDF Request for Notice is attached and filed, which will then add the requestor to the creditor mailing matrix. An attorney filing a Notice of Appearance and Request will need to file it through the CM/ECF system.

- Two new ECF events coming soon that you may see docketed in your cases:
 - Trustee Services Rendered Pursuant to 330(e)
 - Entry made by the Chapter 7 trustee if case qualifies
 - Trustee Payment Under 11 U.S.C. Section 330(e)
 Processed
 - Entry made by Court's Finance Department upon payment

THIS AND THAT

Installment Payments

- The debtor picks the dates and amounts so please track to make sure installments are timely paid.
- Review the Filing Fee or Deadline category under Query to see when payments are due or if the full fee has been paid.
- If the debtor needs more time, a motion to extend time can be filed.

Withdrawals

- Use the Motion-Withdraw Document ECF event if you are attaching a pdf motion to withdraw document and need an order on your motion.
- You can use the Withdraw Document ECF event under Other Filings/Other if you desire to attach a pdf that is not a motion; otherwise, there is also a Withdraw Document (text entry) ECF event available. The text event asks for the name and date of the document you are withdrawing.

Motions to Sell

- We are seeing more creditor responses to motions to sell.
- If you know the terms the creditor desires (timeframe for sale or payoff or adequate protection language, for example), please include them in your motion.
- If a response is filed, please submit a proposed order with terms to address the response instead of relying on a court text order.
