## Re-Entry Court Celebrates First Graduates

On Feb. 3, 2011, the first participants in the Western District's Re-Entry Court program graduated, demonstrating their personal achievement and the success of the program itself, which is designed to provide an alternative for individuals on federal supervised release with significant substance abuse treatment needs.

U.S. District Judge Ortrie D. Smith presided over the graduation session of Re-Entry Court and continues to shepherd the program along with U.S.

Magistrate Judge John T.

Maughmer. Re-Entry Court is accomplished through partnerships and collaborations between the court, U.S. Attorney's Office, Federal Public Defender's Office, U.S. Probation and Pretrial Services Office, and various community resources. Its goal is to improve participant outcomes, thereby reducing recidivism, conserving judicial resources and making a positive difference in the lives of the participants.

Judge Smith convened the first Re-Entry Court in 2010 with four voluntary participants. The program spans 12 to 18 months, depending on the participant's progress. Nancy Rainey, Stephen Ingala and Matt Stone, three of the initial participants,

completed all of the program requirements in just a year and received additional rewards for achieving certain milestones. However, failure to abide by the mandates of the Re-Entry Court could have resulted in the imposition of sanctions by Judge Smith, including termination from the program.

At the conclusion of the Feb. 3 session, Judge Smith issued an order reducing the terms of supervised release for Rainey, Ingala and Stone per their completion of the strenuous requirements of the program. They will now return to the traditional caseload of a probation officer for the remainder of their terms of supervision.

After the ceremony, the graduates celebrated their achievements outside the courtroom with family members, friends, employers, members of the Re-Entry Court team and Judge Smith. Of the 15 current participants, it is anticipated three more will graduate this June.

## Gormley's "The Death of American Virtue" Draws Large Audience

On Feb. 10, 2011, author Ken Gormley drew an audience of over 200 people to the Plaza Library for discussion of his book "The Death of American Virtue." The event was co-sponsored by the Federal Court Historical Society and the Truman Library Institute. The audience was treated to a fascinating presentation by Gormley, a 1980 Harvard Law graduate and the dean at Duquesne University School of Law. His narrative is considered the definitive account of that polarizing period in American politics that led to the impeachment and trial of President Bill Clinton.

Gormley was the Historical Society's most recent speaker in a series designed to bring in authors whose work touches on some significant legal aspect of American or regional history. The next visiting author will be announced later this summer.



## Judge Sachs Shares a Personal Encounter With Dr. Martin Luther King Jr.

In April 1957, Dr. Martin Luther King Jr. spoke in Kansas City at the St. Stephens Baptist Church at Truman and Paseo. And U.S. District Judge Howard F. Sachs was there to hear the speech and to shake Dr. King's hand. In celebration of Black History month, Judge Sachs described his encounter with Dr. King to court employees, recalling that the Kansas City speech concluded with the very "free at last" phrasing that would later be part of Dr. King's famous remarks on the mall in Washington, D.C. Judge Sachs spoke at the court's annual "Soul Food Sampler" luncheon, and this year's event was hosted by the court's newly formed Diversity Council.



In addition to Judge Sachs, Cordell D. Meeks III, president and CEO of Meeks Multicultural Consulting, spoke on workplace diversity and challenged court employees to be aware of and to celebrate diversity among colleagues and visitors to the court. His dialogue on contemporary issues combined with the glimpse of history from Judge Sachs and the great food made for a successful and educational event.

## Online Case Opening Tips

Attorneys have been opening cases electronically in our District Court since Oct. 13, 2009. This enhancement has proved very successful and has allowed the court to better meet the needs of the bar. Cases can be opened 24 hours a day, seven days a week, including holidays. Based on what we are hearing and seeing with regard to this new feature, attorneys may want to take note of the following suggestions:

1. A review of the case opening video and/or the written materials found on our website prior to starting the case opening process will assure compliance with our procedures and will save you time and frustration. You can find those materials at <http://www.mow.uscourts.gov/district/rules.html>.
2. If you have questions after initiating the case opening process or believe you may have made an error, then contact the court. Please do not abandon the new case and try again, as this will cause duplication of cases. If it is after hours, you may contact one of the after-hours numbers available on our website at [http://www.mow.uscourts.gov/after\\_hours.html](http://www.mow.uscourts.gov/after_hours.html).
3. When opening a new case, you are given the opportunity to select the office to which the case should be assigned. Be sure to select the office based on [Local Rule 3.1](#), which offers instructions on assigning a case to the proper division. If an incorrect division is chosen, the court will reassign the case and will also assign a judge from the proper division. Correct initial selection prevents delays.

We hope these tips will improve your case opening experience. If you have any questions, our office is always happy to assist you.

## CM/ECF – Submission of Proposed Orders and Summons

Beginning Monday, April 4, 2011, two new options for District Court cases will be added to the civil and criminal menus. The following is a brief description of these new options.

### E-Mailing a Proposed Order

1. To submit a proposed order, click the E-Mail Proposed Order link, which can be found on the civil events menu and the criminal events menu.

2. Select the judge assigned to the case. In criminal cases, the magistrate judge referred to the case should be selected for all pretrial matters. The Prisoner Pro Se link should be selected for all cases referred to that department.
3. Once the selection has been made, the user's e-mail program will open and populate the e-mail address of the courtroom deputy or clerk associated with the selection. The user should complete the e-mail by including a brief explanation and attaching the proposed order or document.

*Note:* To use this feature, ensure your Web browser is configured to use your primary e-mail application.

### E-Mailing a Summons to be Issued

1. To submit a summons to be signed and sealed by the court, click the E-Mail Summons to be Issued Link on the Civil Menu. After clicking on the link, the following screen will appear.

A summons, including those for cases assigned to the St. Joseph or Southwestern Divisions, can be issued by any of the offices listed above.

2. Once the selection has been made, the user's e-mail program will open and populate the e-mail address for the selected office.
3. Complete the e-mail by including the case number and attaching the completed summons to be issued.

### CJA Guidelines Review

Have you ever finished a case and completed your CJA 20 voucher and discovered that the In Court work and Out of Court work exceed the current \$9,700 statutory cap? What happens when this occurs? What am I required to do?



The CJA Guidelines state the following:

In any case in which the total compensation claimed is in excess of the statutory case compensation maximum, counsel shall submit with the voucher a detailed memorandum supporting and justifying counsel's claim that the representation given was in an extended or complex case, and that the excess payment is necessary to provide fair compensation.

---

The CJA Guidelines further state that a case is complex if the “legal or factual issues...are unusual, thus requiring the expenditure of more time, skill and effort by the lawyer than would normally be required in an average case,” and that a case is extended if “more time is reasonably required for total processing than the average case.”

A voucher that exceeds the statutory case compensation maximum requires review and approval of the presiding District Court judge as well as the chief 8th Circuit judge. In their consideration of the voucher presented, they will review the worksheets detailing the work done as well as the supporting memorandum justifying the claim that excess payment is necessary to provide fair compensation. When the analysis is complete, the judge will determine whether the claim for excess compensation has been met.

In addition to submitting a supporting memorandum, counsel can include form CJA 26—Supplemental Information Statement for a Compensation Claim in Excess of the Statutory Case Compensation Maximum. Form CJA 26—Guidance to Attorneys in Drafting the Memorandum Required for a Compensation Claim in Excess of the Case Compensation Maximum details helpful insight into preparing the required memorandum.



## 2010 WDMO Bankruptcy Statistics

Each year at this time, the court compiles statistical data to assist in district review and planning.

While filings of bankruptcy petitions climbed 14 percent nationally, filings in Western Missouri rose only 3.4 percent. Chapter 13 filings increased 13.6 percent, with Chapter 7 filings staying nearly the same. The 10-year data to the right demonstrates filing trends following the implementation of the Bankruptcy Abuse Prevention and Consumer Protection Act of 2005 (BAPCPA).

### 8<sup>TH</sup> Circuit to Sit in Kansas City

The 8<sup>th</sup> Circuit Court of Appeals will once again hold oral arguments in Kansas City from May 10 through May 13. The panel of 8<sup>th</sup> Circuit judges will vary and includes Chief Judge William J. Riley, Judge Michael J. Melloy, Judge Lavenski R. Smith, and Judge Duane Benton. District Judge James E. Gritzner (Southern District of Iowa) and Senior District Judge Lyle E. Strom (District of Nebraska) will also sit in Kansas City that week.

Note also, there will be a special session honoring the retirement of Senior Judge John R. Gibson, beginning at 4 p.m. on May 10.

## Clerk's Corner

### Budget Woes

Congress continues to debate the budget and is now funding the federal government by temporary "continuing resolutions." For the federal courts, this means that we do not know when we will get our appropriated funds or how much we will ultimately get. This makes planning difficult, but there is some good news for our attorneys: A government shutdown does not mean that they will "turn off" CM/ECF or that all court proceedings would automatically be canceled. To the contrary, the Administrative Office of the U.S. Courts is working to ensure that essential court functions continue regardless. We live in unprecedented budgetary times, so any guarantees would be foolish. But plans are in place to minimize disruption to court services or an attorney's ability to fulfill his or her obligations to the court or their clients. And rest assured that should anything affect federal practitioners, we will always notify attorneys directly rather than expecting you to get information about us from the media. As I reminded our employees during these uncertain times, budget woes are challenging but must be kept in perspective when compared to real disasters like those facing the citizens of Japan.

### About the Speakers

Wedoff

U.S. Bankruptcy Judge Eugene R. Wedoff has served in the Northern District of Illinois in Chicago for 17 years, and he also served as chief bankruptcy judge from 2002 through 2007. Judge Wedoff's recent publications include "Means Testing in the New § 707(b)," 79 *Am. Bankr. L.J.* 231 (2005), and he is the author of the chapter on professional employment in Queenan, Hendel and Hillinger's "Chapter 11 Theory and Practice" (LRP Publications, 1994). Judge Wedoff is a frequent lecturer, having presented papers on a variety of consumer and business issues. In 1995, Judge Wedoff received the Excellence in Education Award from the National Conference of Bankruptcy Judges. Judge Wedoff drafted the model Chapter 13 plan currently used in the Northern District of Illinois.

Laurie L. Levenson is a professor of law, William M. Rains fellow and the David W. Burcham chair in Ethical Advocacy at Loyola Law School. She has written books on California criminal law and is a frequent television commentator on criminal legal issues, first coming to fame as a frequent commentator for CBS in the O.J. Simpson trial. She has written about the ethics of being a television commentator. While in law school, Levenson was chief articles editor of the *UCLA Law Review*. After graduation, she served as law clerk to the Hon. James Hunter III of the U.S. Court of Appeals for the 3rd Circuit. In 1981, she was appointed assistant U.S. Attorney, Criminal Section, in Los Angeles, where she was a trial and appellate lawyer for eight years, and attained the position of senior trial attorney and assistant division chief.
