Sachs Receives "Difference Maker" Award

Senior District Judge Howard F. Sachs received the "Difference Maker" award on December 1, 2016 from the Urban League for his role as a "Civil Rights trailblazer". The Urban League noted that Judge Sachs was being recognized for a lifetime of service to his community; for his thoughtful approach applying the law to advance and protect civil rights; and his steady and persistent dedication to the ideals of fairness and equality for all Americans. This recognition included his role in the Swope Parkway Swimming Pool case, his leadership in 1955 to integrate the all-white, all-male Kansas City Bar Association, and his efforts in 1956 in getting Kansas City to ban discrimination in hotels and restaurants.

In 1957, when a group of white civic leaders forced out the sitting Urban League Executive Director, Judge Sachs helped smooth the transition to new leadership by stepping in as board chair.

Once Kansas City adopted a Fair Housing ordinance in 1968, a referendum effort to repeal the provision immediately ensued. Then, when Martin Luther King, Jr. was assassinated and riots broke out in the city, Sachs and Spencer Fane colleague Bob Lyons convinced Mayor Ilus Davis to invoke an obscure emergency clause to keep the question off the ballot.

The Difference Maker Award is the highest honor annually bestowed by the Urban League of Greater Kansas City. Past recipients include Donald and the late Adele Hall, retired Sen. Christopher "Kit" Bond and U.S. Congressman Emanuel Cleaver.

Congratulations to our friend and colleague on this well deserved recognition!

UPGRADE YOUR PACER ACCOUNT

As federal courts prepare to implement the next generation of the Case Management/Electronic Case Filing system (NextGen CM/ECF), you may have noticed changes in the PACER website (www.pacer.gov). These changes include the opportunity to upgrade your PACER account, which provides enhanced security for all users and easier access for those who file in federal courts. While the Western District of Missouri has not yet set a specific date for implementing NextGen CM/ECF, you can begin to prepare now by upgrading your PACER account.

NOTE: CJA attorneys are instructed NOT to upgrade their PACER account at this time.

What has changed?

1. **Username:** You will choose the username (8 or more characters) for your upgraded PACER account. For security reasons, shared PACER accounts will no longer be permitted (see Firm Billing).
2. **Security:** Accounts now require more complex passwords and a more secure password reset process.
3. **Firm Billing:** Groups can pay for multiple PACER accounts in one bill. Firms will no longer be able to share a single PACER account. Each user must create an individual account and the office manager can use a PACER Administrative Account to manage billing for the individual accounts.

Why have these changes been made?

The implementation of NextGen CM/ECF and the need for upgraded PACER accounts came about for two reasons:

1. Users requested the ability to have one login for all access (PACER and e-filing). This will be implemented when the WDMO moves to NextGen CM/ECF.
2. Security improvements were necessary to keep PACER in line with industry standards.

How do I upgrade my account?

New District & Bankruptcy CM/ECF Events–Interpleader Funds

Beginning **April 1, 2017**, attorneys must use the following motion events in CM/ECF for registry deposits and disbursements in interpleader cases under 28 U.S.C. Section 1335:

- 1) Motion for Interpleader Deposit (28 U.S.C. Section 1335).**
- 2) Motion for Interpleader Disbursement (28 U.S.C. Section 1335).**

For non-interpleader cases, the standard motion to deposit/invest funds and motion for disbursement of funds should continue to be used.

Sharon has been an invaluable member of the Clerk's Office for almost 37 years. During her tenure with the Court, Sharon worked for all of the Bankruptcy Judges, with the exception of Judge Jack C. Sharon's retirement is a great loss and she will be extremely missed. After having



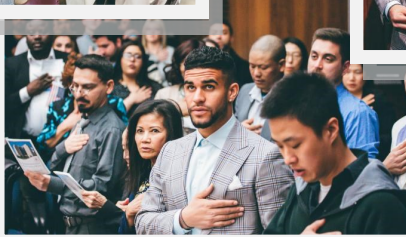

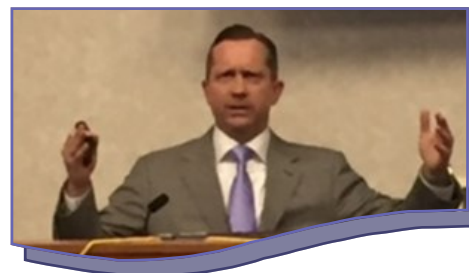

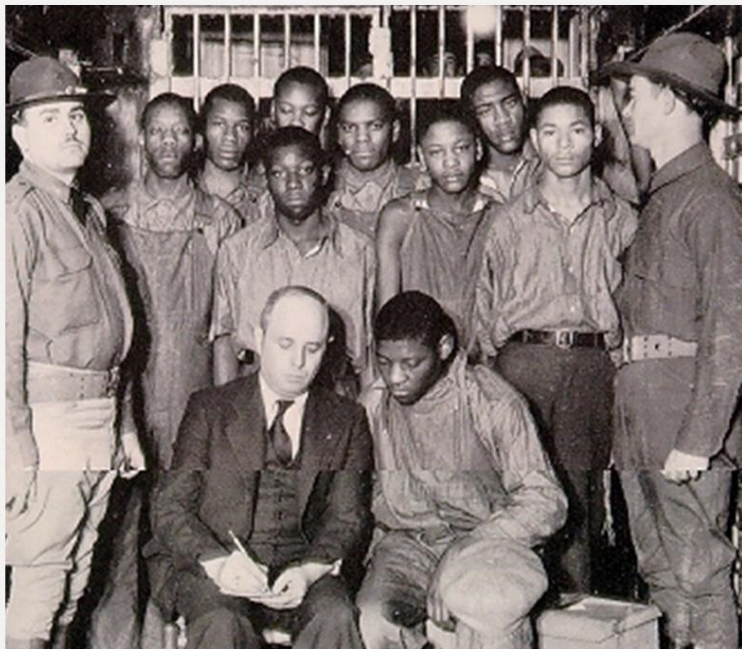

The Scottsboro Boys were nine African American teenagers accused in Alabama of raping two White American women on a train in 1931. The landmark set of legal cases from this incident dealt with racism and the right to a fair trial. The cases included a lynch mob before the suspects had been indicted, all-white juries, rushed trials, and disruptive mobs. It is frequently cited as an example of a miscarriage of justice in the United States legal system.
