Clerk's Office Filing Tips

→ **New Rule and Form: Motion for Personal Property Tax Waiver - MOW 3097-1.1**

- Instead of a 21-Day Notice, this new form includes a 5-Day Notice.
- A separate Motion to Expedite is no longer needed.

→ **Amended Chapter 13 Plans - Statistical Information**

- When filing an Amended Chapter 13 Plan, you should still select the statistical information that has carried over from the previous plan.

→ **Proposed Orders**

- The Court enters orders in a text format on the court docket. If specific language is required in an order, a proposed order shall be submitted to the assigned courtroom deputy **via e-mail** (See [Appendix 1-4](#)) after the hearing or expiration of the response deadline. The proposed order shall be submitted in **Word format** and include signature blocks entitled Submitted By, Approved By, and/or Approved as to Form and Content as applicable.

Objections to Claim Service - Rule 3007(a)(2)

See Rule 3007(a)(2): Whom to Serve; Manner of Service

For Service of the Claim Holder:

- First class mail to noticing address on the POC
- if for the United States, its official officers or agencies - Service must be made per Rule 7004(b)(4) or (5)
- If for Insured Depository Institution - Service must be made per Rule 7004(h)

The notice and objection must also be served, by mail (or other permitted means), on:

- the debtor or debtor in possession;
- the trustee; and
- if applicable, the entity that filed the proof of claim under Rule 3005.

Bankruptcy Rule 3002.1

3. Official Form 410C13-N (*Trustee's Notice of Disbursements Made*)
4. Official Form 410C13-NR (*Response to Trustee's Notice of Disbursements Made*)
5. Official Form 410C13-M2 (*Motion Under Rule 3002.1(g)(4) to Determine Final Cure and Payment of the Mortgage Claim*)
6. Official Form 410C13-M2R (*Response to [Trustee's/Debtor's] Motion [Under Rule 3002.1(g)(4)] to Determine Final Cure and Payment of the Mortgage Claim*)
7. Official Form 410S1 (*Notice of Mortgage Payment Change*). Form is amended to provide space for an annual HELOC notice.
8. Director's Form 4100C (*Order Determining Whether Defaults Have Been Cured and Postpetition Amounts Paid*).
