

NOTICE RE JUNE 30, 2025, CHAPTER 13 DOCKET

The court will conduct the Chapter 13 docket on June 30, 2025, by **telephone using the new Zoom audio conference hearing line.**¹ **ALL PARTIES WILL PARTICIPATE TELEPHONICALLY. ONLY COURT PERSONNEL WILL BE ALLOWED IN THE COURTROOM.**

Please note that the court has sorted the Chapter 13 docket by last name of the debtor's attorney² and divided the docket into **two groups**.
