

## **NOTICE RE JULY 21, 2025, CHAPTER 13 DOCKET**

The court will conduct the Chapter 13 docket on July 21, 2025, by **telephone using the new Zoom audio conference hearing line.**<sup>1</sup> **ALL PARTIES WILL PARTICIPATE TELEPHONICALLY. ONLY COURT PERSONNEL WILL BE ALLOWED IN THE COURTROOM.**

Please note that the court has sorted the Chapter 13 docket by last name of the debtor's attorney<sup>2</sup> and divided the docket into **two groups**.
